OFFICIAL RULES and WINNER AFFIDAVIT

PLEASE READ THESE OFFICIAL RULES CAREFULLY. BY ENTERING THE RAFFLE, YOU UNCONDITIONALLY AGREE TO AND ACCEPT THESE RULES. OPEN TO LEGAL RESIDENTS OF THE UNITED STATES AGES 18 AND OLDER. THE RAFFLE IS VOID WHERE PROHIBITED BY LAW.

DATES:

- The Disney Vacation Raffle is an ongoing yearly raffle. The prize drawing will be held each year at Sunfest in Ocean City, MD. The final date of the raffle drawing will be posted when Believe In Tomorrow's event schedule is set. Please check www.BelieveInTomorrow.org/DisneyRaffle for the most current drawing date.
- Believe In Tomorrow, at its sole discretion, may move the date of the drawing by up to 90 days if deemed necessary.

ELIGIBILITY:

- Must be a legal resident of the United States.
- Must be eighteen (18) years of age or older to participate.

ENTRY:

- Tickets are \$1 for once chance, \$5 for seven chances, and \$10 for twenty chances.
- By purchasing a ticket, purchaser enters this raffle and accepts and agrees to be bound by all the rules, regulations, limitations, and restrictions set forth herein.

PRIZES:

- Prizes are for the private use of the winners as stated in the "Winner Affidavit" and may not be used for any other fundraising activity by the winner(s).
- All federal, state and/or local tax consequences and liabilities are the sole responsibility of the winner of any and all prizes. Winner may be required to provide his/her SSN before prize is released.
- Per IRS Publication 526, the ticket price is not deductible as a charitable contribution for federal income tax purposes.
- It is strongly recommended that winners consult a tax advisor. WINNER SELECTION, NOTIFICATION, AND

VERIFICATION:

- A ticket represents a chance to accept the stated prize(s) subject to all terms and conditions set forth herein and in the "Winner Affidavit". Winners will be notified by phone call/voicemail and will have fourteen (14) days from said phone call/voicemail to accept the prize and sign and deliver the "Winner Affidavit" to Believe In Tomorrow per instruction.
